● For children

1. Financial assistance

- ① Childcare Benefits (income restrictions apply)
Eligibility: Parent(s) or guardian of student up to junior high school age
- ② Childcare financial assistance (income requirements apply)
Eligibility: Single parent of a child or guardian, etc. of a child with a severely disabled father or mother.
- ③ Special childcare benefits (income requirements apply)
Eligibility: Parent or guardian of a child with moderate or severe mental or physical disability. The benefit is provided until the child reaches the age of 20.
- ④ Benefits for disabled childcare (income requirements apply)
For a child who has a severe mental or physical disability and requires constant help in daily activities. The benefit is provided until the child reaches the age of 20.

2. About Daycare Centers and Certified Centers for Early Childhood Education and Care

Daycare centers provide childcare services for families who are unable to look after their children at home for work or other reasons. Certified Centers for Early Childhood Education and Care accept children regardless of whether their parents are working or not and provide integrated education and childcare services. 1. Disability ID booklet

There are three kinds of ID booklets for disabled people: Shintai Shogaisha Techo (ID booklet for the physically disabled), Ryoiku Techo (ID booklet for the intellectually disabled), and Seishin Shogaisha Hokenfukushi Techo (ID booklet for the mentally disabled).

1. 各種手当の支給

- ① 児童手当 (所得制限あり)
対象 中学校修了前の児童を養育している人
- ② 児童扶養手当 (所得制限あり)
対象 ひとり親家庭の児童や、父親または母親が重度の障害を持つ児童を養育する保護者等
- ③ 特別児童扶養手当 (所得制限あり)
対象 身体または精神に中度以上の障害を持つ20歳未満の児童の父もしくは母、または父母に代わって養育している人
- ④ 障害児福祉手当 (所得制限あり)
身体または精神に重度の障害を持ち、常時介護を必要とする20歳未満の児童
